#### Dare's commissioners vote to send housing money back to the state

"Send the money back," said Dare County Commissioner just after noon on April 9, 2024. At a specially called Dare County Board of Commissioners meeting, the commissioners listened to 30 citizens voice opposition to projects tied to Coastal Affordable Housing, LLC. No one spoke in support though several offered suggestions about solving the "housing issue." The only motion of the session was to halt the project. Grant County Manager authority to unwind the project. Return the money. All commissioners voted in favor of the motion. The "money" is the \$35 million granted by North Carolina to Dare County for affordable housing. County Manager Robert L. Outten said he would contact the North Carolina Office of Management and Budget about what to do.

Those speaking from the podium criticized the board's actions and Coastal Affordable Housing LLC, asked for transparency in government and offered suggestions about what to do about the lack of affordable housing in the county.

Applauded was the demand to cut ties with Coastal Affordable Housing LLC and send the \$35 million back to the State of North Carolina.

"Walk away from it. Send it back. It's not a good fit. Go back to square one," said Cynthia Holda, representing the board of the Manns Harbor Civic Association, the only group to offer comments.

County Manager Robert L. Outten outlined the steps the county and the commissioners have taken on a four and a half year journey.

In the budget bill, \$35 million was granted to Dare Count, but strings were attached, including that the project must be a public-private partnership. Outten said a Request for Qualifications was issued. Three entities applied.

The commissioners awarded a \$12 million project on Bowsertown Road to Woda Cooper. The company developed two projects. The Bowsertown project was twice turned down by the Town of Manteo. A second project was proposed for Nags Head, which put on a moratorium and then changed the zoning. Woda Cooper withdrew.

Outten introduced the last agenda item: Where do we go from here?

"I stand ready to follow your direction," said the county manager.

Each commissioner voiced comments.

Said Commissioner Rob Ross, "we have strived for four and half years to make housing available. We have not been successful."

Commissioner Ervin Bateman thought "we can make things happen here. It didn't work out." Bateman said "I'm done. I want to proceed forward. I don't know what we're going to do....It's time to cut our losses and go forward.

Board Chair Robert L. Woodard said, "Unfortunately, this is not the time and place for Dare County to approve essential and workforce housing. It is clearly NIMBY [not in my backyard]." Woodard said he would keep the Housing Task Force in place to see if they can come up with something. The Housing Task Force meets April 16, at 9 o'clock in the Dare County Administration Building in Manteo.

Suggestions for solving the housing issue were offered by speakers. Some would involve negotiating with the General Assembly to repurpose the current legislation and keep the \$35 million in Dare County. Others offered specific government actions requiring new regulations.

# Early college planning underway

Dare County and interested parties are moving rapidly toward building a Dare County Early College on the new College of The Albemarle campus in Manteo.

Currently, the building will be around 28,000 square feet in two stories. At its maximum, the Early College will have 350 Dare County students.

The first meeting of the county's Capital Improvements Planning Committee to consider the design and campus placement for the early college was held April 10, 2024. A second meeting is set for this Tuesday, April 16, 2024, in Room 168, Dare County Administration Building, 954 Marshal C. Collins Dr., Manteo, at 10:30 a.m.

Participating in that initial meeting were representatives from five entities: Dare County Board of Commissioners; Dare County Schools; College of the Albemarle and Town of Manteo, where the new COA campus is located. The selected firm of Oakley Collier Architects, brought five folks to the meeting.

The established timeline calls for the first class for Dare County Early College to start in Fall 2025 in a refurbished existing building on Twiford Road and to open the new facility in Fall 2026.

Outten told the group that \$21 million of the estimated \$25 million needed for the project will come from lottery funds and the remainder from state sales tax revenue. Both sources must be used for schools.

Programming space estimates call for 17 classrooms, three spaces for a media center, a commons and kitchen, nine offices, storage, conference room, four spaces for guidance, three spaces for staff support, three spaces for fitness center, general storage and custodian.

Dare County Schools and College of The Albemarle need to consult on what spaces can be shared.

# No paving on Flowers Ridge Road

On Friday afternoon, the Cape Hatteras National Seashore released a decision on paving the entrance to Flowers Ridge Road in Buxton.

"As a result of feedback received from the public during a two-week-long comment period, including residents who live on Flowers Ridge Road in Buxton, decision makers of the Cape Hatteras National Seashore have decided not to pave the 400-foot-long section of the road that leads into the private neighborhood.

The Seashore requested funding for the road paving project years ago as a result of resident concerns related to maintaining the gravel driving surface on Flowers Ridge Road. While the proposed project would reduce routine maintenance and provide for smoother transportation, residents in the area shared thoughtful concerns related to public safety, an increased likelihood of speeding, and potential confusion if Seashore visitors see the paved surface and think that it leads to Seashore facilities or visitor areas.

The media release states that the Seashore will continue to communicate with adjacent landowners and periodically grade the gravel entrance of Flower's Ridge Road.

#### Insurance companies ask for more to insure mobile homes

Insurance commissioner Mike Causey announced that the North Carolina Rate Bureau has asked for another rate increase.

This one is the increase mobile home insurance premiums 82.9% for fire coverage over three years and 49.9% increase on home casualty insurance.

There are about 148,000 mobile home insurance policyholders in North Carolina.

State law specifies how requests for increased premiums are to be handled.

North Carolina's process is different from other states. In other states, insurance companies file for rate changes individually. In our state, the Rate Bureau files rate requests on behalf of all the insurance companies writing property and casualty insurance in the state.

Now that the Rate Bureau has made its request, a public comment period starts. To comment on the proposal, email <u>2024MH@ncdoi.gov</u>, or write to Kimberly Pearce, 1201 Mail Service Center, Raleigh, N C 27699-1201.

The deadline for comments is April 30, 2024.

Causey has 50 days to say yes or no. If the rate increase is rejected, then Causey must set a hearing date. After the hearing, Causey has 45 days to issue a ruling. The Rate Bureau must decide to accept the ruling or appeal to the North Carolina Court of Appeals.

It's always possible that a settlement could be reached at any step along the way.

#### **Business fire in Buxton**

Uncle Eddy's Frozen Custard and Mini-Golf in Buxton was significantly damaged by fire just after midnight Thursday, reported the Island Free Press.

The Buxton Volunteer Fire Department was dispatched at 12:13 Friday morning, along with Hatteras and Frisco Volunteer firefighters. Also at the scene were deputies from the Dare County Sheriff's Office and Dare County Emergency Medical Services staffers

The fire was brought under control in about 45 minutes, according to Deputy Chief Jeffrey Del Monte of the Buxton department.

As of Friday, the cause of the fire was unknown.
