## Weekly News Summary for Sunday, November 16, 2025.

On Nov. 14, In a bipartisan collaboration, North Carolina Governor Stein and the state's Commissioner of Insurance Mike Causey called on Congress to pass HR3161, the Preventing Environmental Hazards Act of 2025, a bill co-introduced by NC Congressman Murphy and joined by Maine Congresswoman Chellie Pingree, NC Congressman Davis, NC Congressman Rouzer and U.S. Representative Wittman of Virginia.

HR3161 will create more proactive support for coastal homeowners whose homes are at risk of collapse. Since September, severe weather events have caused 15 houses in Buxton and one in Rodanthe to collapse into the ocean, spreading debris for miles and creating safety hazards. North Carolina Gov. Josh Stein and the state's Insurance Commissioner Mike Causey sent a joint letter to the leaders of the House Financial Services Committee.

A new organization has formed on the Outer Banks to take on one of the region's most persistent challenges — protecting Hatteras and Ocracoke Islands from the growing impacts of erosion, flooding, and infrastructure decay, reports the Island Free Press. The Defenders of Croatoan, founded by Buxton Civic Association co-vice presidents Brian Harris and Jeff Dawson, will serve as a policy and advocacy group dedicated to securing funding and influencing decisions that affect coastal resiliency and the long-term future of the islands, especially NC Highway 12. The group's mission statement makes its purpose clear: "Defenders of Croatoan will strive to protect Hatteras and Ocracoke through policy & advocacy. Lobbying at all levels, we will shape decisions that support environmental and business resiliency. We will have a seat at the table; and in the right rooms."

The creation of the organization comes after several years of mounting frustration among island residents who say the local, state, and federal response to erosion and storm damage has been too slow and fragmented. While the Buxton Civic Association will continue to focus on community-based projects, the new organization's reach will extend across both islands, with a mandate to directly engage with policymakers in Raleigh, Washington, and beyond. **The North Carolina Rate Bureau** has proposed significant insurance rate increases for dwelling policies. This type of policy is used for second homes, vacation rentals, and year-round rental properties. The proposed rate increase for beach areas in Dare, Currituck and Hyde counties, or Territory 110, is 40.6% for each year 2026 and 2027. The proposed rate increase for non-beach areas in Dare, Currituck, Hyde and Pamlico counties, or Territory 130, is 37.4% for each year 2026 and 2027.

The proposed rate increases were filed by the NC Rate Bureau Oct. 30, 2025. The last dwelling rate increase approved by the state's Department of Insurance became effective November 1, 2024.

The Outer Banks Association of Realtors© argues that the 2024 rate increase has not been in place long enough to adequately evaluate effectiveness. Rate increases of 14.9% and 5.8% for territories 110 and 130 respectively for extended coverage dwelling policies have been in place for only12 months.

The association also argues that back-to-back double-digit rate increases in 2026 and 2027 are unsustainable for North Carolina property owners. The first rate increase, set for July 1, 2026, is proposed for 40.6% and 37.4% for the respective territories. The second increase, on July 1, 2027, is proposed for the same percentages based on the previous year's base.

The deadline to submit comments is November 19, 2025. When submitting comments, include your name and North Carolina property address. Dare County has joined the association in urging North Carolina Insurance Commissioner Mike Causey to deny the 2025 Dwelling Rate Filing.
