## Weekly News Summary for Sunday, September 28, 2025.

**Yesterday**, Governor Josh Stein declared a State of Emergency and stated "North Carolinians across the state should prepare for tropical weather to bring heavy rainfall and potential flooding. This State of Emergency will enable North Carolina's State Emergency Response Team to mobilize resources and prepare for potential impacts. Forecasts remain uncertain, so it's important that North Carolinians get prepared now, have emergency kits ready, and listen to local emergency guidance to stay safe and informed."

The State Emergency Response Team is readying swift water rescue teams, search and rescue task forces, law enforcement, National Guard, and other resources to support local response and logistical needs.

North Carolina residents and visitors are advised to follow their local government and local news outlets on websites and on social media.

On Sept. 23, 2025, at 6:42 a.m., Cape Hatteras Electric Cooperative experienced an island-wide power outage. An hour later, at 7:41 a.m., the cooperative updated its Facebook information. The power outage was caused by salt accumulation on a fuse at the Pea Island Visitor Center. The crew washed the fuse and reset it.

At 8:23 a.m., the cooperative announced that all power was restored. "If your power did not come back on, please call 866-511-9862...."

At the scene, Josh Austin and Silas Hooper were in the bucket and did the washing on the fuse and insulators. Counting Josh and Silas, 10 cooperative workers were at the incident. Earl Fountain, the cooperative's operations manager, was on the scene. When the washing was done, he called the Buxton office. Someone pushed a button and power was restored. The crew waited five minutes and the power stayed on.

North Carolina Division of Marine Fisheries Proclamation FF-34-2025 proclamation closes the Pound Net Northern Management Area on September 28, (that's today) at 6 p.m. for commercial purposes in Internal Coastal, Joint Fishing Waters and Atlantic Ocean Waters. This proclamation maintains all other gear management areas opening date of October 1, 2025. This action is being taken to comply with the requirements of Amendment 4 to the N.C. Southern Flounder Fishery management Plan and maintain harvest within the total allowable landings. **On October 7**, Dare County is accepting sealed bids for the Buxton and Hatteras Stormwater Improvement Project. Submissions are due by 11 o'clock.

The project calls for a series of stormwater management upgrades in Buxton and Hatteras Village designed to address persistent flooding and drainage problems.

The scope of work includes improvements to roadside swales, installation of infiltration trenches and perforated HDPE pipes, culvert work, grading corrections, and the creation of a bioswale system along N.C. Highway 12 near the eastern entrance to Hatteras Village.
